## **Case Scenarios**

- 1) You are in a small church and currently only have one musician that is willing to play for Sunday worship, and though he has a good demeanor and attitude, is not very good with his instrument. What can you do to improve the situation?
- 2) Your church has a few musicians that can play decently for congregational worship, but they have very different preferences in musical styles and they do not get along with each others. What can you do to improve the situation?
- 3) Your church has a couple of decent musicians (stringed instruments) and one musician that is an excellent pianist but who has a very proud attitude that demands music in the church is done her way because she knows best. This has caused the other musicians to begin to refrain from working with her. How will you handle the situation?

- 3) You have a praise team that leads the congregational music at least once a month which provides a very good variation in musical styles for the congregation. It has come to your attention that the leader of the team is not walking with the Lord properly and has entered into an inappropriate relationship. How will you handle the situation?
- 4) Your church is starting to grow as new families move into your area. Your church has been very traditional in its style and forms of worship. As you interview the new families who are coming you find that they are attracted to the church because of its high commitment to the Scriptures as the Word of God and ability to explain the Bible so that they are encouraged to live according to it. However, you also find that many are having a hard time connecting emotionally in worship because the hymns being used are not just unfamiliar to them, but contain a lot of archaic words they do not understand and are sung in ways that seem almost depressing. Some of the newcomers do have musical ability and have offered to get involved to help improve the congregational music. How would you respond to them? What options are available to you to make changes? What might you say to the current musicians and potential new ones about the criteria that would be used for picking psalms, hymns and spiritual songs for congregational worship?
- 5) As #4 above, but the new family expresses that they are considering looking for a new church because they are finding it so hard to worship in your church? How will you respond?
- 6) As #4 above, but older musicians express that they refuse to play any of the newer songs being produced. The hymns they are using were good enough for their parents and grandparents, so it is good enough for them and their children. How will you respond?
- 7) A newer musician wants to introduce a new song to the congregation. Upon review you find that it has one line of lyrics that boarders on being heretical and another that is simply confusing about what it means. The tune is very singable and the rest of the song is theological sound. How will you respond, what are your options?
- 8) You have someone complain to you that a new song that was used in congregational worship was written by someone who was now theologically aberrant if not heretical and is also concerned that the copyright information published would encourage the young people to go to those publishers to get more similar types of songs. You had reviewed the song and found it to be very theologically sound and fit well its purpose for being used in congregational worship. How will you respond? How can you help alleviate the concerns and also express any validity to the concerns?
